"Take a Dip Down South" CONTEST

Contest Rules (the "Rules")

NO PURCHASE NECESSARY.

1. CONTEST AND CONTEST PERIOD

The "Take a Dip Down South" Contest (the "Contest") is organized by Les Rôtisseries St-Hubert Ltd. (the "Organizer"). The Contest begins on October 20, 2025, at 00:00:01 a.m. Eastern Time (ET) and ends on November 24, 2025, at 11:59:59 p.m. ET (the "Contest Period"). The clock used by the Organizer will be the official clock that determines the date and time of receipt of an Entry (as defined below).

2. ELIGIBILITY

To be eligible to participate in the Contest, individuals must meet the following criteria at the time of Entry in the Contest (as defined below): they must be legal residents of Quebec, Ontario, or New Brunswick and must have reached the age of majority in their province of residence at the time of entry (the "Participant" or collectively, the "Participants").

This excludes employees, directors, administrators, shareholders, officers, representatives and agents of the Organizer, as well as those of its subsidiaries, associated companies, franchisees, affiliated companies, advertising and promotional agencies and suppliers of prizes, and members of their immediate families (father, mother, sisters, brothers, children), legal or common-law spouses, and any persons with whom they are domiciled, whether or not they are related to them.

Each Participant must enter exclusively on their own behalf and be acting for their sole personal benefit.

3. HOW TO ENTER

Go to https://www.st-hubert.com/en/contests/south-trip.html to fill out the online entry form and validate it as indicated. All data input fields on the entry form must be filled in unless the information is optional. Upon clicking the Submit button, the Participant is entered in the Contest (an "Entry").

Each online entry is an "Entry."

By entering the Contest, the Participant agrees to comply with these Rules and the Organizer's privacy policy, available at https://www.st-hubert.com/en/privacy.html.

<u>Limit</u>: A Participant may obtain only one (1) Entry for the entire Contest Period.

Entries that are mechanically reproduced, falsified or altered are void. The Organizer is not responsible for Entries that are lost, late, not submitted or invalid. Such Entries will be disqualified. All Entries become the sole property of the Organizer and will not be returned to Participants.

Any attempt by a Participant to obtain more Entries than allowed by using multiple email addresses, identities, registrations, login credentials, or any other methods, will result in the cancellation of all of the Participant's Entries, and said Participant may be disqualified at the sole discretion of the Organizer. The use of an automated system (including, but not limited to, the use of bots, scripts, macro commands or other automated services to submit Entries) to participate is prohibited and will result in the Participant's

disqualification. In the event of a dispute regarding the identity of an individual who submitted an Entry, the authorized account holder of the email address used will be deemed to be the Participant. The "authorized account holder" is the person assigned to the email address by the Internet service provider, online service provider or organization responsible for assigning the account for the email address. Selected Participants may be required to provide proof that they are the authorized holders of a given account.

4. THE PRIZE

As part of the Contest, there will be three Draws (as defined below) and three (3) Prizes (as defined below) available to be won from online entries submitted during the eligible period, including one (1) Grand Prize and two (2) Other Prizes.

The Grand Prize consists of one (1) trip valued at seven thousand dollars (CAN\$7,000) to Club Med, one (1) St-Hubert gift card valued at five hundred dollars (CAN\$500) redeemable at St-Hubert rotisseries, and fifteen (15) coupons valued at twenty dollars (CAN\$20) each and three hundred dollars (CAN\$300) total, redeemable for St-Hubert retail items by December 31, 2026, at any point of sale in Quebec (the "Grand Prize").

Each Other Prize consists of one (1) travel credit worth one thousand dollars (CAN\$1,000) to be used exclusively with Voyages Gendron, one (1) St-Hubert gift card worth two hundred and fifty dollars (CAN\$250) redeemable at St-Hubert rotisseries, and five (5) coupons worth twenty dollars (CAN\$20) each and one hundred dollars (CAN\$100) total, redeemable for St-Hubert retail items by December 31, 2026, at any point of sale in Quebec (each an "Other Prize").

The Grand Prize travel prize consists of:

A. One (1) stay for two (2) adults, the Winner and one (1) guest, at one of the following Club Med accommodations, subject to availability and at the discretion of Voyages Gendron: Cancun, Mexico or Punta Cana, Dominican Republic (the "**Destination**"). The total value of the Grand Prize trip is seven thousand dollars (CAN\$7,000), including taxes.

- i. Seven (7) nights' accommodation in a minimum-category double occupancy room at the Club Med at the Destination;
- ii. Two (2) round-trip economy class plane tickets departing from the Montréal-Pierre Elliott Trudeau International Airport to the Destination;

- vi. Club Med membership fees of sixty dollars (CAN\$60) per adult for the Winner and their guest;
- vii. Applicable taxes.

b. For the sake of clarity, the following are not included in the Grand Prize travel prize:

- Airport transfers;
- ii. Meals other than those mentioned, particularly when travelling;
- iii. Travel, health and/or cancellation insurance;
- iv. Excursions and/or sports activities not offered free of charge by the Club Med;

- v. Personal purchases;
- vi. Telephone calls, roaming charges and mobile data charges;
- vii. Wines, champagnes or spirits à la carte;
- viii. Gratuities.

There are a total of three (3) Prizes available to be won in the Contest. The Prizes are worth a total of ten thousand five hundred dollars (CAN\$10,500). The value of the Prizes is in Canadian currency and does not include applicable taxes, if any.

Limit: Maximum of one (1) Prize per Participant.

The final travel dates and times will be determined by Club Med, which reserves the right to select a date and destination based on availability. Bookings will be accepted on the basis of availability exclusively dedicated to the Winner (and not the availability of regular sales) and can only be confirmed 90 days or fewer prior to departure. They cannot be combined with any other promotion.

- The Prize must be accepted as described in these rules and may not under any circumstances be, in whole or in part, transferred to another person, substituted for another prize or exchanged for cash.  set out herein and without limiting their scope, Voyages Gendron is not liable in the event that
 the use of the Grand Prize travel prize is impossible due to a force majeure event, including,
 without limitation, a pandemic.
- Gendron Travel is not responsible for any event that may prevent or delay travel and/or affect
 accommodation bookings or any activities booked by the Winner and their guest at the
 destination.
- The Winner waives all recourse if the services offered are not fully satisfactory.

Terms and conditions of one (1) travel credit valued at one thousand dollars (CAN\$1,000)

The Winner agrees to and undertakes to comply with the following conditions of use:

5. SELECTING WINNERS AND AWARDING PRIZES

On December 1, 2025, at the Organizer's office, located at 1755 Lionel Bertrand Boul. in Boisbriand, QC. There will be three (3) draws (each a "**Draw**" and collectively the "**Draws**"). The Draws will consist of randomly selecting three (3) Entries from among the eligible Entries received during the Contest Period.

The Organizer or a designated representative will make at least one (1) attempt to contact the selected Participants within three (3) business days after the Draw by email or telephone using the information provided at the time of placing the order or on the Contest entry form. Each selected Participant shall contact the Organizer no later than forty-eight (48) hours after being notified as mentioned above, as per instructions given by the Organizer. If, at the end of three (3) business days following the Draw, a selected Participant is unable to be contacted, or if the notice sent to the selected Participant is returned as undeliverable, or if the Participant has not contacted the Organizer within forty-eight (48) hours after the Organizer's notice, the Participant will, at the sole discretion of the Organizer, be disqualified and forfeit all rights to the Prize. In such cases, the Organizer reserves the right, at its sole discretion, to conduct another Draw from the eligible Entries to award a Prize following the above-mentioned contact procedure.

To be declared a Prize winner (the "Winner"), the selected Participant must meet the eligibility criteria for the Contest and the validity criteria for entering set out in section 2 above, and must meet the following requirements:

- 1. Sign a "Release of Liability" sent by the Organizer to, among other things, (i) confirm having complied with these Rules; (ii) indicate acceptance of the Prize as awarded; (iii) assign all rights held in any material provided by the Participant when entering the Contest, if applicable; and (iv) release the Beneficiaries from any liability arising from this Contest. - 3. At the request of the Organizer, if applicable, provide an additional piece of photo identification.

The Winner will be put in contact with Voyages Gendron to book their trip. The Winner and their guest must agree to receive communications from Voyages Gendron for booking and travel purposes.

The Winner will receive their St-Hubert gift card valued at five hundred dollars (CAN\$500) for the Grand Prize and valued at two hundred and fifty dollars (CAN\$250) for an Other Prize by mail or email.

The Winner will receive their coupons for St-Hubert grocery items, redeemable at any point of sale in Quebec, by mail.

Contest conduct and disqualification. Rules shall remain in effect and shall be construed as though the non-applicable provision were not contained herein. The headings are for reference purposes only and should not affect the interpretation of the Rules.

Limitation of liability. as provided for in these Rules, a technical problem or other circumstance that, in the opinion of the Organizer, may adversely affect the proper administration of the Contest, or for any other reason, subject to approval by Quebec's *Régie des alcools, des courses et des jeux* (the "**Régie**"), if required.

Contest suspension. Without limiting the generality of the foregoing, if the Contest, or any part of the Contest, cannot proceed as planned for any reason due to, including but not limited to, a computer virus or bug, tampering, unauthorized intervention, fraud, programming errors or technical malfunctions that the Organizer, at its sole discretion, deems to corrupt or disrupt the administration, security, impartiality, integrity or normal conduct of the Contest, the Organizer may, at its sole discretion, subject only to approval by the Régie, void any suspicious Entry, and: (a) terminate the Contest, or any part of the Contest; (b) modify or interrupt the Contest, or any part of the Contest to correct the problem and restart the Contest, or any part of the Contest, in a manner that better respects the spirit of these Rules and/or; (c) award Prizes among the compliant eligible Entries received prior to the discovery of the problem, in accordance with the winner selection criteria set out herein.

Language. In the case of an inconsistency between the French and English versions of these Rules, if an English version exists, the French version shall prevail.

Régie. Any dispute respecting the organization or administration of a promotional contest may be submitted to the *Régie des alcools, des courses et des jeux* for ruling. Any dispute respecting the awarding of a prize may be submitted to the *Régie des alcools, des courses et des jeux* solely for the purpose of helping the parties reach a settlement.
