#### HOW TO ENTER

- To enter, purchase a \$3 scratch card at one of the sales sectors of participating St-Hubert rotisseries and St-Hubert Express (dining room, counter and delivery).
- Cards are on sale from June 1<sup>st</sup>, 2022 to September 30<sup>th</sup>, 2022 or while supplies last.
- Cards are numbered from 000001 to 103000.
- Customers can buy more than one card per person.
- Purchase is final and non-refundable.

#### PRIZES

- Total value of prizes is approximately three hundred and seventy-three thousand three hundred and forty-eight dollars (\$373,348 CND), taxes included.
- Value of St-Hubert menu items is based on takeout meal prices.
- Value of paddle boards is based on the retail price.
- When purchasing a card, you have one in three chances of winning:
  - Inflatable paddle board 125 X
  - Zoo meal 7 990 X
  - Fish & Chips meal 1 647 X
  - Cheese sticks (4) 5 600 X
  - When purchasing a meal, switch your fries for a poutine at no extra cost 4 980 X
  - Vanilla cake 18 000 X
  - Oatmeal cookie 3 564 X
  - Vegetable juice 340 ml 1 500 X
  - Eska sparkling water 500 ml 3 000 X
- Items from the St-Hubert menu shall be redeemed on the next visit upon presentation of the winning scratch card only.
- Prizes shall not be redeemed at delivery.
- Prizes cannot be redeemed for cash nor substituted.
- Winners of a paddle board shall be required to complete and sign a liability waiver form to receive their prize.
- Depending on stock availability, winners may need to wait a few weeks before collecting their paddle board at the rotisserie.
- Prizes may be redeemed at rotisseries until December 31<sup>st</sup>, 2022 at 8 p.m.

# **CLAIMING PRIZES**

- To claim a St-Hubert menu prize item, winners shall go to any St-Hubert rotisserie and present their winning card.
- To claim the paddle board (1) prize, winners shall:
  - $\circ$  Go to the rotisserie where they purchased their card and present their winning card; and
  - Complete and sign a liability waiver form within forty-eight (48) hours and return it to the rotisserie BEFORE collecting their paddle board; and
  - Correctly answer the mathematical skill question on the liability waiver form.
- Each instant prize shall be accepted as is and cannot be transferred, accessed, or converted into cash (unless expressly allowed by the Organizer in its sole and absolute discretion).
- No substitutions are allowed, except at the discretion of the Organizer.
- The Organizer reserves the right, in its sole and absolute discretion, to substitute a prize with one of equal or greater retail value.

### GENERAL CONDITIONS AND ELIGIBILITY

- The draw is open to anyone residing in the provinces of Quebec, New Brunswick, and Ontario, and who have reached the legal age at the time of contest entry.
- Employees, representatives and/or agents (and/or residing with such employees, representatives or agents, whether related or not) from either contest party shall not be eligible to win an instant prize.
- The draw Organizers reserve the right to amend or end the draw at any time without notice, subject to approval from the *Régie des alcools, des courses et des jeux du Québec*.
- The draw is subject to applicable federal, provincial and municipal laws.
- By entering this draw, winners authorize the draw Organizers and their representatives to use, if so required and for advertising and promotional purposes, their name, city of residence, photograph, image and/or statements related to the draw, indefinitely and without any form of compensation.
